Overview

SNI Indonesia is the only standard valid throughout the Indonesian territory, formulated by the National Standardization Agency (BSN). It covers everything from technical specifications to testing methods for various industrial sectors. The implementation of SNI is not mandatory, except for products related to. Indonesia's rapid expansion in international trade has driven the evolution and enforcement of standards across nearly all industrial sectors. Foreign investors often find themselves caught in a complex web of certifications. This regulation became effective on 2 June 2025.
