EXCEPTION: Passage to enclosed equipment installed within the elevator machine room to provide the ventilation required by Section 3011 (f) (2) (A). (4) Elevator machine rooms or enclosed areas shall be kept free of all materials except those used for repair or. (1) Elevator driving machines, motor generator sets, controllers, and auxiliary control equipment shall be installed in a room or enclosure set aside for that purpose. Exception: Existing installations of cabinet-type machines. 51 indicates that the location of elevator disconnects need to be, something about, accessible to qualified persons. 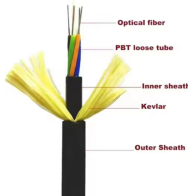
